Reasoning:

The Contracting Authority selected to conclude the Contract with the Supplier whose bid was evaluated as the most economically advantageous according to the result of the bid evaluation while the Selected Supplier meets all the conditions for participation in the procurement procedure for the Public Contract. With regard to the aforementioned and in accordance with Sec. 122 (1) PPA, the Contracting Authority decided to select the Supplier 1 - **NUVIA a.s.**, IČO: 25506331, with its seat at Modřínová 1094, Nové Dvory, 674 01 Třebíč.

The Supplier will not use sub-supplier to perform the subject matter of the Public Contract.

10. Reasoning for not dividing Public Contract into parts

The reason for this Public Contract not being divided into parts is the fact that the subject of the Public Contract represents a homogenous whole lacking any classification by individual domains; the Contracting Authority anticipates that the complete subject of the Public Contract will be executed fully by one single Supplier meeting the terms and conditions hereof.
