

Notification of changes to Tender documentation

The Contracting Authority hereby announces a changes to the tender documentation (hereinafter referred to as "TD") within the framework of the Dynamic Purchasing System (hereinafter referred to as "DPS") and also to the DPS setting itself, see the summary below:

- 1) The Contracting Authority responds to the change in factual circumstances by extending the duration of the DPS until 2028, see paragraph 4, point 3) TD as follows: "The Dynamic purchasing system will last until 31 December 2028 or until the financial value that was set by an assumed value for the duration of the DNS";
- 2) the above-mentioned change is also related to the modification of the DPS name, i.e. keeping the entire name, but without indicating the original annual DPS duration range, see the TD header, i.e. the original wording of the name shortened by "2018-2024";
- **3)** there was also a change in the contact persons of the Contracting Authority in paragraph 2 of the TD;
- **4)** the basic business terms and conditions were modified, see paragraph 5 TD in the amended wording: "The negotiated price is the maximum permissible price, with the exception of changes to the obligation according to § 222 of the Act";



- **5)** expanded paragraph 6 of the TD with information on the possibility of explaining the TD in partial public contracts;
- **6)** there is a change in the qualification conditions for professional competence, i.e. the condition of providing documents proving professional competence no older than 3 months before the start of the procedure (or submission of an application for participation) is deleted, see paragraph 8.1 TD;
- **7)** information was added according to the PPA about the possibility for the Contracting Authority to request at any time during the duration of the DPS the submission of an updated Unified European certificate for public procurement by the supplier, see paragraph 8.1 TD;
- 8) within the framework of paragraph 10 of the TD, the text was clarified according to PPA § 140 (1 and 2), i.e. the obligation of the Contracting Authority to decide within 10 days on the delivery of the request for participation and to send the notification without unnecessary delay from the decision;
- 9) within the framework of paragraph 11 of the TD, foreign language translations have been clarified according to the PPA, i.e. the obligation to translate into Czech or English does not apply to documents beyond the scope of documents required by the Contracting Authority, as well as documents in the Slovak language and documents of education in the Latin language are submitted without translation. The Contracting Authority may waive the obligation to submit a translation for other documents as well;
- **10)** within paragraph 13 of the TD, the wording is amended to a new text: "The rules for submitting documents according to § 45 of the Act and proving qualifications according to § 81 to 85, § 87 and 88 of the Act shall be applied similarly throughout the duration of the DPS. The Contracting Authority may, at any time during its duration, assess the fulfillment of the reasons for ineligibility according to § 48 (5 or 6) of the Act";
- **11)** the text of Annex No. 1 to the Tender Documentation (Sample of the request for participation_DNS_10_2024) is being modified in accordance with the above name change, plus the addition of the text on the issue of "sanction lists" as part of the affidavit to EU legislation.

The Contracting Authority has made a change to the conditions of participation with regard to changes in legislation as well as its experience from previous use of DPS. The nature of the changes made to the Tender documentation and the settings of the DPS itself could expand the range of possible participants.

The currently valid wording of the TD can be found on the Contracting Authority's profile at the relevant DPS in the Procurement documentation section.
